**Subject: "Requirement of DGCA Medical Assessment Class 1/2/3 Medical Examinations"**

Presently, DGCA Medical assessments are issued for every medical examinations conducted for Class 1, 2 and Class 3 medical assessment at IAF Boarding Centers, Empanelled Medical Examiners and approved DGCA Empanelled Aeromedical Evaluation Centers/Hospitals.

2. It is hereby notified that the following revised guidelines for **issue of Medical Assessment** in respect of Class 1, 2 & Class 3 will come into effect from **01 Sep 2025**. Periodicity, schedule and validity of medical examination of each category (Class 1, 2 & Class 3) will remain the same as per existing rules and regulations of DGCA.

3. The revised guidelines for issue of DGCA Medical Assessment is mentioned at following Para (a). For interim period and for all other categories not enumerated in Para (a), a **Fit Medical Certificate** i.e. CA-35 issued by DGCA Empanelled Medical Examiner/ IAF Boarding Centres/ DGCA Empanelled Aeromedical Evaluation Centres/ IAF Renewal Centres will be valid for exercising all the privileges of the DGCA Licenses.


(a) Revised periodicity/requirement of issue of Medical Assessment as per criteria such as age and type of medical for Class 1 and Class 2 is as follows:

(vii)	For issue and renewal of various DGCA Licenses, ratings and any other certifications.	As per extant policies.	As per extant policies.

\* Applicants can directly apply for Class 1 Initial Medical Examination on the basis of Fit Medical Certificate i.e. CA-35 issued by Class 2 Medical Examiner.

4. Existing Rules, Regulations and modalities for Class 3 and Cabin Crew Medical Examinations remains the same.
5. DGCA may conduct scrutiny of any of the submitted medical applications randomly. Any observation/remarks/disposal rendered during these random checks will be applicable as and when issued from the date of issue of Medical Assessment.
6. DGCA empanelled Medical Examiners/ IAF Boarding Centres / Aeromedical Evaluation Centres/hospitals should exercise due caution and ensure correctness of CA-35, wherever DGCA Medical Assessment is not mandatory.
7. Civil Aviation Requirements (CARs) and respective modalities in eGCA module with respect to Medical Examination of DGCA License Holders would be amended in due course and will be notified on DGCA website.
