**Cabin Safety Circular 01 of 2025**

**SUBJECT: REPORTING PROCEDURE FOR PASSENGER  
MISCONDUCT / PASSENGER RAGE / UNRULY BEHAVIOUR**

**1. INTRODUCTION**

In the recent past, number of incidents involving unruly passengers during the conduct of the flight have taken place, posing a threat to the safety of the flight and /or its passengers, crew, or its properties.

Wherein it is observed that post holders have substantially delayed or not reported the matter pertaining to passenger misconduct/passenger rage/ unruly behavior to the regulatory authority.

**2. APPLICABILITY**

This Cabin safety circular is applicable to all Scheduled Operators, Scheduled Commuters, and Non-Scheduled operators and all operators who carry cabin crew on board an aircraft.

**3. REPORTING TO DGCA**

This cabin safety circular is issued to reiterate that the procedure to report such passenger misconduct / passenger rage/ unruly behavior shall be adhered to for maintenance of safety of the flight and /or its passengers, crew, or its properties.

The information is to be immediately reported by Chief of Flight Safety/ Director Cabin Safety (In Flight Services) within 12 hours via email, and detailed written information should be submitted to DGCA within 24 hours of the landing of the aircraft as per the enclosed Performa.

#### 4. REPORTING PROCEDURE

It is the responsibility of Director Cabin Safety (In Flight Services) of the airline to report all such incidents to Director (Flight Standards Directorate, DGCA HQ) and in addition, by the airline Chief of Flight Safety to Director Air Safety / Regional Air Safety Office in whose region the flight lands after the incident and to Director Air Transport (Aircraft Engineering) on his/her email Id as per the enclosed performa.
